# INMATES RECEIVE FIRST DOSE OF COVID VACCINE

### **COVID UPDATE**

On April 28, 2021, inmates housed in the Jefferson County Jails began receiving doses of the Moderna Covid 19 Vaccination. All inmates were given the opportunity to sign up to receive the vaccine.

The vaccines were furnished and administered by the Jefferson County Department of health. The funding for the vaccines was provided by the federal government.



This initiative was implemented to help slow the spread of Covid 19 within our facilities. It benefits both the inmates and the corrections personnel for as many people within those facilities as possible to be vaccinated. Those inmates receiving the vaccine will be able to receive the second dose when they are due.

### The Leader of the Pack – Sergeant Danny Barrett & Kady

In 2007 Sergeant Danny Barrett came to the Jefferson County Sheriff's Office, much like most Deputies, wanting to make a difference. Sergeant Barrett had been in Law Enforcement with Adamsville Police Department since 1995. While he was happy working for Adamsville, he recognized that there were many more opportunities within a larger department.



Sergeant Barrett worked through the ranks with the Sheriff's Office and found himself on the Highway Safety Unit. This division works major thoroughfares and interstates attempting to stop drug transportation and human trafficking from utilizing our roadways, and catching them if they try. During this assignment, Sergeant Barrett was assigned to work with Deputy Naiyah.

K-9 Deputy Naiyah

In 2019, Sergeant Barrett was promoted to his current position as Sergeant. With this promotion, Sergeant Barrett became the Supervisor over the Jefferson County Sheriff's K-9 Unit.

Sergeant Barrett and his supervisor, Lieutenant Kerry Morgan have been instrumental in adding a few new faces, furry ones, to the K-9 Unit.

Currently, the unit employs 5 tracking dogs, 5 bomb/explosives dogs, 8 drug detection dogs, and 1 human remains detection dog. Sergeant Barrett has been instrumental in getting 5 of those K-9 Officers donated to the Sheriff's Office. He has also been a huge part in their training. Sergeant Barrett has implemented intense training for these dogs and their handlers.

Today, Sergeant Barrett is still working with the Highway Safety Team, but he has a new up and coming partner. K-9 Deputy Recruit Kady is working with Sergeant Barrett. He is making sure that Kady knows the ropes around here.

It can be hard to see Kady as a working girl, as she is one of the cutest K-9 Deputies you will ever meet. Even though she has one of the most precious faces you will ever see on a Deputy, Kady is going through rigorous training so that she can become a full-fledged drug dog. She goes through schools and certifications and is with Sergeant Barrett 24 hours a day, 7 days a week.



Even though Kady is focusing on her training and learning to be the best that she can be, Sergeant Barrett allows her to have a little downtime to be a dog. She even has a spot at home where Sergeant Barrett says Kady likes to watch television.

Interaction with Kady can be a bit overwhelming right now, as Sergeant Barrett explained to me that discipline and manners are one of the last things that these dogs are taught. If a K-9 in training is disciplined and 'reigned in' too early, it could hamper their drive to work. It does help that they are taught to work on a reward-based system. If they find their target, being a person, narcotics, explosives, weapons or even a body, they are given a reward. It is usually a favorite toy that they get to play with.

# CITIZENS CAN NOW SUBMIT ANONYMOUS CRIME TIPS



The Jefferson County Sheriff's Office has added a feature that will allow citizens to anonymously submit a tip to its detectives. The Sheriff's Office recognizes that often times people want to send information directly to the detective who is working on a case, but may not want to be identified.

In addition to working with Crime Stoppers, we have added a link to our homepage at www.jeffcosheriffal.com, for the public to send those tips to detectives. For those looking for a reward, the tips must go directly through Crime Stoppers, but now there is an additional option if you are not wanting a reward.

The tip link went live on Friday night, May 14, 2021 and had already received multiple tips by Monday morning.

### NEW "REDEEMER ACT" HELPS THOSE IN JOBS NOT JAIL PROGRAM FIND NEW LIFE

### NEW LAW UPDATE



Sheriff Mark Pettway is teaming up with Attorney Chris Burrell of Burrell and McCants, LLC to help those who are seeking employment assistance through the Jefferson County Sheriff's Office's 'Jobs Not Jail' program. Governor Ivey signed the law that will go into effect on July 1, 2021.

This new law will allow those who have been convicted of a non-violent crime to apply to have their record expunged. The expungement of these offenses would allow people to be able to have a clean record when they apply for a job.

Those who have signed up for Sheriff Pettway's "Jobs Not Jail" initiative will be able to have their attorney's fees waived by Attorney Burrell. This means, Burrell and McCants will handle the paperwork at no charge. Participants will still be responsible for the filing fees to the courts, but no attorney fee will be charged.

## SHERIFF PETTWAY WANTS COMMUNITY MEMBERS TO FOCUS ON JOBS, NOT JAIL

Jefferson County Sheriff Mark Pettway has been working to make the needs of the citizens of Jefferson County a priority since the day he was elected. The reduction of crime is obviously the at the top of those priorities.Putting someone in jail is a necessary part of fighting crime in Jefferson County, but there are other avenues that could have a positive effect on that reduction.

When looking at how to stop crime before it occurs, one must consider why crime occurs. There are many reasons, but one of the main reasons could be lack of employment. Sheriff Pettway feels so strongly about being able to fight this reason for crime that he has developed a new program to help alleviate the unemployment problem.

"Jobs, Not Jail" was developed from a partnership between the Jefferson County Sheriff's Office and Kortni Sheffield at This Generation Recruitment. The project is pointed at providing meaningful employment to the citizens of Jefferson County. Every 2nd and 4th Friday of the month, the Jefferson County Sheriff's Office will take its Mobile Command Unit, known as the 'Job Mobile' during these events, to a different area of Jefferson County and help to provide job seeking skills free of charge to the public. Job seekers will receive aid with resume writing, interview skills, ID support, jobs, and more at no cost.

In addition, This Generation Recruitment will work with the applicant to help them find meaningful employment. Kortni knows how important this step is to individuals and to the community. Her business' mission statement declares that they focus on providing their applicants with careers that will give them a sense of purpose, confidence, and stability.

That sense of purpose, confidence and stability may be just the change someone needs when they are at a crossroads in life. These staples in life will help to keep our community members in need of these services on the right path, and in turn, make Jefferson County a safer place.
